AGREEMENT

THIS AGREEMENT (hereinafter referred to as the "Agreement") is made on the **19th day of April**, Two Thousand and Twenty-Four (**2024**) and entered into:

By and Between

BSE Institute Limited, a Company incorporated under The Companies Act 1956, having its registered offices at 25th Floor, P J Towers, Dalal Street, Mumbai 400 001, India (hereinafter referred to as "**BIL**") (which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns) of the **One Part**.

And

Gokhale Memorial Girls' College, represented by Dr. Atashi Karpha, situated at 1/1 Harish Mukherjee Road, Kolkata-700020.

BSE Institute Ltd and Gokhale Memorial Girls' College, Kolkata shall hereinafter be also jointly referred to as the "**Parties**" and severally as the "**Party**".

AND WHEREAS the parties of the first and second party have appreciated each other's objectives in promoting excellence, inter alia, in education in the common area of interest and are desirous of entering into an agreement for mutual benefit. They wish to come together for delivery and dissemination of vocational education in BFSI (Banking, Financial Services and Insurance).

Now, therefore, in consideration of the foregoing and the mutual covenants set forth herein, the Parties hereto agree as follows:


1. PROGRAM DETAILS:

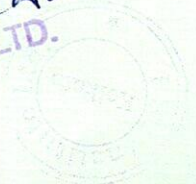
1.1 Program Name and Duration

1.2 BSE Institute Ltd and Gokhale Memorial Girls' College, Kolkata may add more programs from time to time during the period of Agreement. The parties shall mutually discuss the details of the course/program before the launch of the course/program.

2 FINANCIAL:

Rs. 2,999/- per student (Inclusive GST) for the 30 Hours Program or Rs 4499/- per student (Inclusive GST) will be collected by the college from students. The amounts collected shall be remitted to BIL online before the commencement of respective batch.

It is hereby clarified that BSE Institute shall commence the courses only upon receipt of upfront payment as mentioned herein above.

3 BATCH SIZE:

To have financial feasibility for BSE Institute and Gokhale Memorial Girls' College, Kolkata, the parties agree to attempt a composition of batch of at least 50 students and 2 batches (June-July and Nov-Dec) per Academic year.

In case the composition of batch size is less than 50 then commencement of batch will be subject to mutual discussion between the parties on financial feasibility.

4. FACULTY AND SUPPORT STAFF

BSE Institute Limited will appoint the Faculty Coordinator on appropriate remuneration for the purpose of conducting the course.

5. RIGHTS AND OBLIGATIONS OF BIL & GOKHALE MEMORIAL GIRLS' COLLEGE, KOLKATA

It is mutually agreed between BIL & Gokhale Memorial Girls' College, Kolkata that they shall have the following rights and obligations for the purpose of this agreement: -


Role and Responsibilities of BIL:

- To design and develop content and teaching material for the program.
- To provide BSE certified trainers for conducting the training program.
- To conduct Classes and exams for students enrolled under the program.
- To undertake regular audits for execution of program.
- To evaluate feedback from students.
- To support the college / university in conducting promotional seminars, and counseling sessions.
- To nominate a Single Point of Contact for day-to-day work.
- Certificate will be provided to successfully course completed Students only with minimum of 80% attendance for BIL Classes.

Role and Responsibilities of Gokhale Memorial Girls' College, Kolkata:

- To inform the course amongst the students.
- To monitor and help minimum number of students per batch as agreed.

- To provide internet access in classroom and Computer lab with adequate bandwidth.
- To investigate admissions of students for the program.
- To provide necessary infrastructure for conducting ILT, webinar and exam.
- To make available assessors for assessment of projects done by students.
- To undertake regular audits for execution of program.
- To evaluate feedback from students.
- To nominate a member as single point of contact for day-to-day work.

5.1 Course Outline

BSE Institute shall prepare a detailed course outline and send it to Gokhale Memorial Girls' College, Kolkata. BSE Institute shall provide each candidate with the detailed course outline at the commencement of the course.

5.2 Faculty

The faculty for the course shall be arranged by BSE Institute in consultation with Gokhale Memorial Girls' College, Kolkata. BSE Institute shall share the details of the faculty members with Gokhale Memorial Girls' College, Kolkata and faculty in-charge for the purpose of coordination of the course.

5.3 Course schedule

The course schedule i.e., the lecture schedule shall be prepared by BSE Institute in consultation with Gokhale Memorial Girls' College, Kolkata and the same shall be shared with candidates at the commencement of the course.

5.4 Course material

BIL shall prepare the study material to be given to candidates. The soft copy of the study material shall be shared with the candidates through.

5.5 Infrastructure

Gokhale Memorial Girls' College, Kolkata shall provide all the infrastructural facilities for conducting the course in Gokhale Memorial Girls' College, Kolkata campus. Gokhale Memorial Girls' College, Kolkata shall, at the least, provide a classroom with projector screen for conducting the lectures.

5.6 Candidate details

Gokhale Memorial Girls' College, Kolkata shall provide to BSE Institute complete details of the candidates within 15 days of the closure of admission. Admissions shall usually close before commencement of the course.

5.7 Faculty Coordinator and support staff

Gokhale Memorial Girls' College, Kolkata shall appoint the Faculty Coordinator on appropriate remuneration for the purpose of conducting the course. The expense for this purpose is deemed to be included in the fees collected from students and this amount would be met from Gokhale Memorial Girls' College, Kolkata's share of the fees.

5.8 Promotional activity

Gokhale Memorial Girls' College, Kolkata shall help BIL for the information of the course by sending mails, brochures and assisting in organizing introductory seminar. However, Gokhale Memorial Girls' College, Kolkata shall not use the name, logo or any other thing related to BSE Institute without its prior approval.

5.9 Course examination

BSE Institute shall be responsible for setting question papers and assignments for the purpose of examination. BIL shall also get the same evaluation by the subject experts. The exams will be conducted by BIL at Gokhale Memorial Girls' College, Kolkata Campus.

5.10 Gokhale Memorial Girls' College, Kolkata faculty as participants

Participation in the course is free for Gokhale Memorial Girls' College, Kolkata faculties provided they do not demand certification post the course.

6. INTELLECTUAL PROPERTY RIGHTS

Gokhale Memorial Girls' College, Kolkata shall not use the name or logo of BSE Institute / BSE/ BIL without their written consent. Similarly, BSE Institute shall not use the name or logo of Gokhale Memorial Girls' College, Kolkata without Gokhale Memorial Girls' College, Kolkata's written consent. Gokhale Memorial Girls' College, Kolkata shall not have any copyright on the study material of the course prepared and distributed by BIL.

It is agreed between Gokhale Memorial Girls' College, Kolkata and BIL that neither party during this agreement shall desire nor intend to transfer any intellectual property rights whatsoever with respect to any information that is proprietary. Gokhale Memorial Girls' College, Kolkata may use the logo and name of BIL for the purposes of this course only by taking prior written permission from BIL for every such use.

7. TERM

This agreement shall remain in force for 1 year unless it is renewed for another term and with new terms and conditions (if any) as mutually agreed by the parties.

8. TERMINATION

Breach of this agreement by either of the parties shall terminate this agreement. In addition to this, it is mutually agreed between Gokhale Memorial Girls' College, Kolkata and BSE Institute that either party can give prior notice of 30 days to terminate the contract. It is further agreed between the parties that irrespective of the termination of the contract, if the course is in progress it shall be obligatory on the part of Gokhale Memorial Girls' College, Kolkata and BSE Institute to ensure the completion of the course according to the above-mentioned terms and conditions.

9. FORCE MAJEURE.

Neither Party shall be liable for any failure or delay in the performance of its obligations under this Agreement to the extent such failure or delay or both are caused, directly or indirectly, without fault by such Party, by any reason beyond its reasonable control, including but not limited to, by fire, flood, explosion, earthquake, elements of nature, drought or bad weather, lightning or acts of God, epidemics or pandemics, acts of state, strikes, acts of war (whether declared or not), hostilities, terrorism, riots, civil disorders or commotion, lockouts, industrial disputes, rebellions or revolutions, blockages; quarantines, embargoes and other similar governmental action (each a "Force Majeure Event"). Any Party so delayed in its performance will immediately notify the other by telephone or by the timeliest means otherwise available (to be confirmed in writing within ten (10) Business Days of the inception of such delay) and describe in reasonable detail the circumstances causing such delay with relevant documentary supporting. However, the Party claiming such event shall take all necessary steps to mitigate the delay so caused despite such Force Majeure Event.

10. DISPUTE RESOLUTION

If any dispute or difference of any kind whatsoever may arise between the Parties in connection with or arising out of this agreement, BSE Institute and Gokhale Memorial Girls' College, Kolkata shall attempt for a period of 30 days after receipt of notice by the other Party of the existence of a dispute to settle such dispute in the first instance by mutual discussions between the Parties. All disputes, differences or questions arising out of this agreement including the interpretation of the terms herein or regarding the obligations, failure or breach of any terms thereof by either of the party under this agreement which have not been mutually settled as per the provisions of this clause shall be referred to arbitration under the provisions of the Arbitration and Conciliation Act, 1996. The Parties shall mutually appoint an arbitrator. The place of arbitration shall be mutually decided between the parties hereto. The language for Arbitration shall be English. The provisions of this clause shall survive the termination of this Agreement.

11. GOVERNING LAW/ JURISDICTION:


The laws of India shall govern this Agreement. Both parties irrevocably submit to the exclusive jurisdiction of the Courts in Mumbai, for any action or proceeding regarding this Agreement.

12. NO PARTNERSHIP OR AGENCY

During the period of this Agreement the relationship of the Parties are of independent contractors. It is hereby understood and agreed that this Agreement is on a Principal-to-Principal basis and neither Party shall describe itself as an agent, partner, joint-venture partner, employee, or representative of the other Party.





