MEMORANDUM OF UNDERSTANDING

This MEMORANDUM OF UNDERSTANDING (hereinafter referred to as "MoU") is made on this 17th Day of January 2024 at Kolkata, West Bengal.

BETWEEN

GOKHALE MEMORIAL GIRLS' COLLEGE, KOLKATA, having its registered office at 1/1, Harish Mukherjee Road, Police Station - Bhowanipur, Kolkata - 700020, represented by Dr. (Mrs)AtashiKarpa as the Principal and (Mrs.) SanchitaSen as the IQAC Co-ordinator, hereinafter referred to as "COLLEGE" (which expression shall, where the context so admits, be deemed to include its successors, executors, administrators, and assigns) of the FIRST PARTY.

AND

GIRL2B FOUNDATION INDIA TRUST, having its office at 14 Russa Road, 2nd Lane (South), Kolkata- 700033, represented by Joy Kar as Trustee, hereinafter referred to as "G2B Foundation" (which expression shall, where the context so admits, be deemed to include its successors, executors, administrators and assigns) of the SECOND PARTY.

First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party'

AND

WHEREAS the FIRST PARTY is **Gokhale Memorial Girls' College** is a distinguished academic institution under the University of Calcutta.

WHEREAS the SECOND PARTY **Girl 2B Foundation India Trust** is a Registered Trust with registered office at Kolkata

WHEREAS both the Parties, being legal entities in themselves, desire to sign this MoU for advancing and exchanging their mutual interests and experience in the relevant field for the betterment of the students to do justice to their potentials.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL CONSENT SET FORTH IN THIS MOU, THE PARTIES HEREIN AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Centre and the College and its related wings. The Parties shall keep each other informed of potential opportunities and structural changes in the schedule as and when

required and shall share all information that may be relevant to secure additional opportunities for one another.

CLAUSE 2: SCOPE

2.1 Internship Opportunities:

- The Centre will provide internship opportunities for students of Gokhale Memorial Girls' College in relevant areas.
- The Centre will conduct orientation sessions and provide necessary resources for the interns.

2.2 Academic Collaboration:

- The Parties will explore possibilities for academic collaboration, including joint research projects, seminars, and workshops in related fields.
- Both parties will mutually agree on the specific areas of collaboration and the modalities thereof.

2.3 Career Counselling:

- Girl 2B Foundation will conduct career counselling sessions for the students of Gokhale Memorial Girls' College, after taking the consent of the college administration, providing insights into various career options and guidance on academic and professional pathways to interested students.

CLAUSE 3: TENURE

3.1 This Agreement shall remain valid and binding upon both parties for a period of two years effective from the date on which it is executed. The MOU may be renewed by mutual consent of both parties.

3.2 The parties herein shall be entitled to terminate this agreement by mutual consent in writing by serving at least 2 (Two) months prior notice to the other party herein, subject to completion of training, internships, or any other ongoing commitments.

CLAUSE 4: RELATIONSHIP BETWEEN THE PARTIES

4.1 It is expressly agreed that the First Party and Second Party are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations, or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Party shall have, nor represent itself as having, any authority under the terms of this MoU to make any arrangements/agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's name, credit or to extend credit on behalf of the other Party.

4.2 It is also agreed that there will be no financial obligations between the parties for this MOU.

CLAUSE 5: DISPUTE RESOLUTION BETWEEN PARTIES

Any divergence or difference or dispute derived/arrived from the interpretation or application of this understanding shall be resolved by invoking the provisions of arbitration between the parties herein as per the Arbitration and Conciliation Act, 1996 (as amended till date). The place of arbitration shall be within the jurisdiction of the Hon'ble High Court, Kolkata, India as per the constitution of the Tribunal concerned. In case any dispute has arisen, the name of the Learned Arbitrator shall be nominated by the First Party herein only. This undertaking is to be construed in accordance with Indian Law having the exclusive jurisdiction of the Courts of Kolkata only.

CLAUSE 6: REVIEW AND AMENDMENTS

This Memorandum may be amended or revised if both parties agree during the aforementioned tenure, as and when required. Such amendments or revision shall be effective immediately from the date of execution. Amendments may be decided at any time and shall be made in writing upon mutual consent of the parties.
