Scholarship for meritorious students belonging to Minority Communities (Buddhist, Christian, Jain, Muslim, Parsees and Sikh)

➤ POST-MATRIC SCHOLARSHIP (For Post-Matric Classes)

- ✦ Students pursuing higher secondary, ITI, Diploma, Graduation, Post Graduation , M.Phil, etc. from recognised institutions in West Bengal.
- ✦ Annual family income of the applicant should not exceed ` 2 lakhs.
- ✦ Scholarship amount ranges from ` 10,200 to ` 16,500 p.a., subject to actual.

IMPORTANT INSTRUCTIONS:

-  Only a candidate domiciled in West Bengal will be eligible.
-  The student must have passed the last examination with at least 50% marks
-  A student is eligible for a scholarship from any one source only.
-  Students pursuing courses through distance mode are not eligible.
-  One mobile number can be used for the registration of one application only.
-  After submitting the online application, the applicant must take a Print-out of the same and submit it to the concerned institute, along with
 - i) A photocopy of bank passbook containing bank account no IFS Code.
 - ii) Self declaration of annual family income.

CHIEF MINISTER RELIEF FUND (NABANNA) SCHOLARSHIP 2019-20

Students of West Bengal can apply for Chief Minister Relief Fund (Nabanna) Scholarship for their higher studies.

Educational Qualification

- ✦ Graduation Level : 60% aggregate marks in Higher Secondary

Others Qualification

- ✦ Candidates must have to be permanent resident of West Bengal.
- ✦ The maximum family income of the family of the candidate must be within 60000 per annum.
- ✦ Only those candidates are eligible, who are not enjoying any other scholarship or stipend in the same course.
- ✦ Students must have to admit in any of the institution in state after either their state board or state aided university.








AMOUNTING SCHEME

- ✦ The Eligible candidates will get Rs. 10000/year of your current course duration.

APPLICATION PROCESS

- 1) There are two process for applying
 - Through Plain Paper – Write a fresh application on own handwriting with sign
 - Through Application – Download and fill up the application form
- 2) Attach the “Recommendation copy of MLA or MP” or”Self-Declaration” copy issued by Head of your current institution.
- 3) Attach the mandatory documents. (Mentioned below)
- 4) Submit the application form at Nabanna, 14th Floor, 325 Sarat Chatterjee Road, Shibpur, Howrah- 711102.

IMPORTANT DOCUMENTS

-  Mark sheets of all previous examination passed.
-  Monthly Family Income Certificate from any one mentioned within the bracket – (DM/ SDO/ BDO / Group-A Govt. Officer not below the rank of Joint B.D.O./ Executive Officer in case of Municipality / Deputy Commissioner of Corporation).
-  Recommendation copy of MLA or MP to the Hon’ble Chief Minister stating monthly family income of the student.
-  Self declaration of the student under his/her signature regarding present course of study mentioning year/semester and receipt of any scholarship / aid/assistance, duly countersigned by the head of the Present institution with seal.
-  Self Bank Account details (IFSC Code, Branch Code, Branch Name, Account Number, Bank Name) with photocopy of Bank Pass Book.
-  Photo Copy of tuition/admission fees book.
-  Contact Details and self-Mobile No.

Scholarship for meritorious and needy students belonging to West Bengal's Minority Communities (Buddhist, Christian, Jain, Muslim, Parsees and Sikh)

➤ **SWAMI VIVEKANANDA MERIT CUM MEANS SCHOLARSHIP SCHEME (SVMCM)**

(For meritorious students from class xi to postgraduate courses)

- ✦ Students of post-matric levels in regular courses are eligible and they must be domiciled in West Bengal.
- ✦ Students studying in educational institutions of this state after clearing the examinations of West Bengal Board of Secondary Education/ Higher Secondary Council/ West Bengal Madrasah Education Board and or from other recognised boards of West Bengal, are eligible.
- ✦ The students must have passed his/her examination in the current year i.e. 2019 only.
- ✦ In case of SVMCM scholarship, applicants who are in receipt of the SVMCM scholarship last year and have the application ID must apply under the **Renewal** category only.
- ✦ Scholarship amount ranges from ` 12,000 to ` 60,000 p.a.

Higher Secondary, Polytechnic & Graduation	75%

➤ **POST- MATRIC STIPEND UNDER TALENT SUPPORT PROGRAM**

(TSP) (FOR STUDENTS SECURING LESS THAN 50% MARKS)

- 1) Students pursuing Higher Secondary, Graduation, Post-Graduation, M.phil, Ph.D., etc. except professional and technical course are eligible.
- 2) Student should have passed with less than 50% marks and passed in the last exam.
- 3) Annual family income of the applicant should not exceed ` 2.00 lakh
- 4) Institute must be located within the West Bengal.
- 5) Scholarship amount ranges from ` 2,550 to ` 4,900 p.a.

IMPORTANT INSTRUCTIONS

-  The student must be a citizen of India and a domicile of West Bengal.
-  Students pursuing courses through distance mode are not eligible to apply.
-  After submitting the online application, the applicant must take a print out of the same and submit to the concerned institute, along with a photocopy of the bank account no. And IFS code.
