The undersigned is directed, by order of the Governor to say that the Governor is pleased to approve of the extension of affiliation in Economics to the degree (Honours) level in Gokhale Memorial Girls' College Calcutta-20 with effect from 1983-84 Session subject to the grant of affiliation in the subject by the Calcutta University.

2. The Governor is ~~further pleased~~ also pleased to sanction payment, during the current financial year, of a non-recurring grant of Rs. 10,000/- (Rupees Ten thousand) only to Gokhale Memorial Girls' College, Calcutta-20 towards purchase of books, for the Economics Department.

3. The Governor is further pleased to approve of the creation of one additional post of Lecturer in Economics at the Gokhale Memorial Girls' College, Calcutta-20 in the usual scale of pay with effect from the current session or from the date of filling up the post, whichever is later.

4. The Deputy Director of Public Instruction (N.G.C.), West Bengal, is authorised to release the non-recurring grant sanctioned in para-2 above in favour of the authorities of the aforesaid college.

5. Certificate of utilisation of the grant now sanctioned should be furnished by the college to the Director of Public Instruction, West Bengal under intimation to this Department within three months from the date of drawal of the grant by the college.

6. The charge for non-recurring grant of Rs. 10,000/- (Rupees Ten thousand) and an account of Staff Salary will be met from the provision under the head - "University & other Higher Education - Assistance to Non-Government Colleges - State Plan (Annual Plan & Sixth Plan) - Development of Non-Government Colleges - Grants-in-aid/Contribution" in the Current year's "277-Education (Excluding Sports and Youth Welfare)" - Budget.
